Rail Equipment:

To assist us in assigning you a storage siding, we ask that you provide us with the following information for **each** locomotive **and** freight or passenger car you plan to bring to the Triennial. If you bring several locomotives, we will attempt to assign all of your equipment to the same track or to adjacent tracks. Please remember that the maximum train length for operating on the main line is 140'.

IF you have a small electric powered locomotive or a speeder, you may be asked to share a charging track with another small unit so that we are not forced to turn people away.

Due to the large number of trains expected at the 2018 Triennial, **ONLY pre-registered trains will be guaranteed a track assignment - which will be based on first come-first served by registration date.** Track assignment guarantees will close on May 31, 2018, or when 400 trains have been registered - whichever comes first.

Those not receiving track assignments may take a chance and bring a train, and if there is a cancellation they may be allowed to unload.
